Ofsted October 2023: What Does the School need to do to improve?
<ul style="list-style-type: none"> ■ Pupils’ behaviour and attitudes are not good enough. There is too much disruption in lessons. This is having a negative impact on the progress pupils are making through the curriculum. Leaders must ensure that the school’s behaviour policy is applied consistently that internal truancy is addressed, and that more is done to improve pupils attitudes to school. ■ The curriculum is not being implemented consistently well in all lessons . This means that pupils experiences of the curriculum are variable Leaders should ensure that the curriculum is implemented consistently well , so that pupils are able to know more, learn more and do more. ■ Some vulnerable pupils , including disadvantaged pupils and those with SEND , are not consistently receiving the support that they need in lessons As a result, these pupils are not making the progress that they should . Leaders must ensure that teaching consistently incorporates support and strategies that help these pupils overcome any barriers that they may face. ■ The weakest readers , including those at the early stages of reading, are not currently getting the support that they need. This means they are not able to access the curriculum as well as they should. Leaders must ensure that a comprehensive programme of support is implemented to teach, assess and monitor the progress of the weakest readers in the school.
